

Privacy Policy, Terms and Conditions

1. What personal information does Oklahoma City Indian Clinic collect?

You may use the Oklahoma City Indian Clinic (OKCIC) site without providing any personal information; however, use of certain services on the site may require personal information.

You may be asked to provide personal information such as name, address, e-mail address, and phone number, choose to submit any of the online forms used, for example, when you:

- register for a class or program
- register for our e-mail newsletter
- respond to surveys and questionnaires
- fill out an online donation form
- request further information

If you choose to make an online donation from our site, you will be to paypal.com to complete the transaction.

Except where OKCIC specifically requests, OKCIC does not wish to receive personal or other confidential information from you via the Internet. It is important to note that OKCIC is in full compliance with the *Health Insurance Portability and Accountability Act (HIPAA)* protecting your privacy, while providing optimum care, is our number one priority. 2. How is the collected information used?

OKCIC uses the collected information only to provide you with the services you have requested. OKCIC will not disclose the personal information you provide on the site to any outside organization except when we have your permission, or as when we feel it is necessary to protect our rights or the rights of others, or as required by law.

3. Does OKCIC use "cookies" to collect user information?

"Cookies" are small computer files that a Web site can transfer to your computer to track Web site use and customize sites according to user preferences. OKCIC does not use cookies on its site at this time.

Often advertisers will place their own cookies on a site user's computer. However, at present OKCIC does not accept third party advertisements on its site.

4. How does OKCIC protect personal information?

OKCIC wants your personal information to remain as secure as possible. Accordingly, we use industry standard efforts, such as secure servers, to protect the confidentiality of your personal information.

5. What about links to other Web sites?

The OKCIC site provides links to other sites that we believe may be of interest to you. Please be aware that this Privacy Policy applies only to the OKCIC site and does not apply to sites that OKCIC links to. We encourage you to read the privacy policies of other sites before providing them with personal information.
